- Sealed tenders are invited from the prominent suppliers of Science Material under two part bid system (party-I Earnest Money (DD or cash receipt) and Technical Bid. In Part-II financial bid. The suppliers are required to prepare two sealed cover super scribed as (i) Cover-I Technical Bid, and (ii) Cover-II Financial Bid. Both covers should be kept in one main sealed cover as "Tender for Supply of Science Materials".
- 2. The tender must be accompanied by Earnest Money of Rs. 4,500.00 The same can be deposited either by cash or Demand Draft in favour of BHEL Shiksha Mandal, Bhopal and shall be returnable to every unsuccessful tenderer.
- 3. Only unit rate should be quoted against each items and the rate should be inclusive of all taxes and for delivery of the materials at respective schools.
- 4. Manufactures name their trade mark and brand, if any should invariably be mentioned in the tender and illustrative leaflets giving technical particulars etc. if any attached to the tender to facilitate considerations of the offer.
- 5. Materials should be best quality and confirm to our specifications. Materials not confirming to these shall be rejected and returned to the supplier at their own risk and cost.
