

QUALIFYING CRITERIA.

1. The bidders shall preferably be those who have been approved by/served to any Government/Semi Government Department/organization.
2. The bidder shall have experience for at least 3 years preferably in Supply and installation of CCTV and shall submit documentary proof in respect of the supply.
3. The firm should have to submit the ITR/ Balance sheet, profit/loss account for the last three years.
4. The firm must have valid GSTIN registration number.PAN, Firm Registration
5. The Supplier should have an Average Annual financial turnover during the last 3 years, ending 31", March of the previous financial years, should be at least Rs. 1,50,810.00
 - (a) Three similar completed supply of costing not less than the amount of Rs. 2,01,880.00each.
 - OR
 - (b) Two similar supply completed costing not less than the amount of Rs. 3,01,620.00 each.
 - OR
 - (c) One similar supply completed costing not less than the amount of Rs. 4,02,160.00.
- 6 All filled details provided in the technical bid (Annexure B) should be enclosed with proper supporting copy of documents.
7. Payment shall be made based on actual quantity of items installed/replaced and consumables used at site as per approved rates quoted by the bidder.
8. Payment of the AMC cameras will be made separately as per total number of AMC covered CCTV.

TERMS & CONDITIONS:-

1. Sealed tenders are invited under two part bid system (Party-I Earnest Money (D/D or cash receipt) and Technical Bid & Part-II Financial bid, from prominent supplier for the supply , installation and CAMC of CCTV at BSM institution.

2. The tender must be accompanied by Earnest Money of Rs.10040.00. The same can be deposited by Demand Draft in favour of BHEL Shiksha Mandal, Bhopal or cash and shall be returnable to every unsuccessful tenderer.

3. The tenderer is required to prepare two sealed cover super scribed as (i) Cover-I Technical Bid, and (ii) Cover-II Financial Bid. Both covers should be kept in one main sealed cover as "Tender for the supply & installation of CCTV."

4. The Technical bid of the tender will be opened on the same day at 15.00 Hrs by the tender Committee of BSM, in its office in the presence of the tenderers of the authorized representative who wish to be present. The date and time for opening of Financial Bid of the technically qualified tenderers shall be communicated later as per convenience of this office.

5. Generally the orders shall be placed on lowest offer for the total items. The Authority reserves the right to reject/cancel any or all the tenders at any time or to relax/amend/withdraw any of the terms and conditions as contained in the Tender documents without assigning any reason, thereof. In case the offer accepted of a party is not executed in the stipulated time for whatever reason, the item can be procured by BSM from other supplier at their price and difference in price shall be recovered from the original supplier from the Earnest Money/Security Deposit. Any inquiry after submission of the tender will not be entertained.

6. The supply and installation of CCTV has to be completed within 25 days from the date of placing order and the supply of the items is subject to inspection by our committee.

7. The rate should be inclusive of all supply and installation charges, taxes/duties and F.O.R. at BSM institutions.

8. Tenderer should visit the BSM institutions as per required quantity mentioned for observing the locations of cameras before the quoting the tender and should also watch for the existing operational CCTV cameras which will be under AMC.

The contractor shall provide Comprehensive Annual Maintenance Contract (CAMC) services for a period of one (01) year for all newly installed CCTV systems under this contract as well as all existing functional CCTV systems installed at various BSM Institution locations. The scope of CAMC shall include preventive maintenance, breakdown maintenance, repair/replacement of defective components, software support, testing, commissioning and ensuring satisfactory performance of the complete CCTV surveillance system.

Based on the satisfactory performance of the contractor during the contract period, the Competent Authority reserves the right to extend the CAMC for a further period on the same terms and conditions or as mutually agreed, subject to requirement and approval.

9. The CCTV and other accessories shall be as per our requirement given in tender specification. In case your supplies differ from the mentioned specifications, BSM may reject the goods or impose penalty as fixed by the President, BHEL Shiksha Mandal.
10. Warranty Terms: One year from the date of satisfactory installation.
11. Bidders shall not approach for refund of EMD till the finalization of the tendering process and award of supply the items to qualifying Tenderer. The offer should remain valid for a minimum period of 90 days. EMD shall be refunded to the unsuccessful bidders within 30 days of award of contract to the successful bidder/bidders.
12. BHEL Shiksha Mandal reserves the full rights to increase/decrease the quantity of items in the tender as per requirement.
13. In all cases of dispute, the decision of the President, BHEL Shiksha Mandal shall be final and binding on both the parties.
14. Failure to supply the items within the stipulated time will attract penalty @ 1% of the order value per week of delay subject to a maximum of 10% of the order value. In such event, the management shall be within their right to cancel the order and procure the materials through any other source at the risk and cost of the supplier.
15. Payment of cable will be made on actual measurement basis and quantity certified by concerned HOI's of the institutions.
16. 90% Payment will be made within 15 days on proper installation and completion certificate receipt from concerned school/department and 10% payment will be released after completion of warranty period.
17. Payment of cameras covered in AMC will be make separately on quarterly basis.
18. Only the financial bids of technically qualified bidders' shall be opened.
