

QUALIFYING CRITERIA

1. The bidders shall preferably be those who have been approved by/served to any Government/Semi Government Schools/organization/ Reputed Schools.
2. The bidder shall have experience for at least 3 years preferably in Annual Maintenance of Smart Classes and shall submit documentary proof in respect of the AMC.
3. The firm should have to submit the ITR/Balance sheet and profit/loss account for the last three financial years (i.e. 2022-23, 2023-24 & 2024-25).
4. The firm must valid GSTIN registration and PAN number.
5. Techno-commercial bid may incorporate with list of main customers with work order/delivery challan.
6. The Service Provider should have an average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least Rs. 4,50,000.00.
 - (a) Three similar completed works costing not less than the amount of Rs. 2,23,200.00 each.

- (b) Two similar AMC work completed works costing not less than the amount of Rs. 2,79,000.00 each.

SCOPE OF WORK

1. Sealed tenders are invited under **two part bid system** (Part –I Earnest Money Deposit (D/D) and Technical Bid & Part-II Financial bid. From prominent Service provider for the AMC of 15 Numbers of Smart classes installed in Jawahar Lal Nehru School (PW).
2. The tender must be accompanied by the earnest money of Rs. 11160.00 the same can be deposited only through cash or demand draft in favor of BHEL Shiksha Mandal, Bhopal and shell be returnable to every unsuccessful tenderer.
3. Firms registered under MSME are exempted from payment of EMD subject to submission of a valid MSME registration certificate covering the nature of work mentioned in this tender.”
4. The tenderer is required to prepare two sealed covers scribed as (i) Cover-I Technical bid, and (ii) Cover-II to financial bid. Both covers should be kept in one main sealed cover as **“tender for annual maintenance of smart classes at JNS (PW)”**.
5. All copies of supporting documents should be presented mentioned in technical bid along with tender documents.
6. The Tenderer has to submit the cover sealed in above manner at BSM Office P&S section or before as the date mentioned above positively. The tender shall not be accepted beyond the stipulated date and time under any circumstances whatsoever.
7. The Technical bid will be opened on 01/11/2025 at 15.30 Hrs by the tender Committee of BSM, in its office in the presence of the Tenderers of the authorized representative who wish to be present. The date and time for opening of Financial Bids of the technically qualified tenderers shall be communicated later as per convenience of this office.
8. The rate should be quoted including taxes, duties and spare parts required for AMC.
9. It will be the sole responsibility of the Service Provider to make assessment of all training work and content for children to all classes of teachers.
10. Contract Period: One year from the date of award (extendable based on satisfactory performance).
11. Response Time: All complaints must be attended to within 24-36 hours.
12. BHEL Shiksha Mandal reserves the right to place the order in full or in part or reject all tender without assigning any reason whatsoever.
13. BHEL Shiksha Mandal reserves the full rights to increase/decrease the quantity of items in the tender as per requirement.
14. Payment Terms: Payment will be made on a quarterly basis against satisfactory performance and submission of service report/ delivery reports forwarded from senior authority of institutions.
15. Penalty Clause: Delay beyond 36 hours in complaint resolution will attract a penalty of Rs. 300 per day.
16. If work completion takes more than 30 minutes it should be done after dispersal of students.
17. Spare Parts: Replacement/repair of defective parts (excluding consumables) shall be the vendor’s responsibility.
18. Content Updates: Educational content/material must be updated periodically to ensure alignment with prescribed curriculum.
19. Termination Clause: The Department reserves the right to terminate the contract at any time by giving 30 (thirty) days’ prior written notice to the contractor.”


